Federal Budget Status





Where Are We Now

FY 2025 is being funded through a Continuing Resolution (CR) expiring Sept. 30, 2025.

H.R. 1, the "One Big Beautiful Budget Act" (OBBBA) passed the House but has not gone before the full Senate for a vote yet.



What This Means

Proposed budget cuts in the OBBBA are not yet law and the Senate is likely to make more changes.

The final version of the OBBBA could dramatically reshape health research, funding, and access to care starting Oct. 1, 2025.



Why It Matters

Administrative changes are already impacting currently approved funding and programs.

The OBBBA as it is currenty written will set deep funding cuts into law, with effects that will be felt well beyond FY 2026.


Direct constituent interactions influence lawmakers' decisions

Relationship Building


Lawmakers place a high value on citizens who have built relationships with them

MEETINGS DON'T NEED TO FEEL INTIMIDATING





Meetings are often with a legislative staffer and not the congress member



Staffers can spend more time with constituents, listening to personal stories



They know we are constituents and not professional lobbyists and aren't experts in government and legislation



Preparation before your meeting will help you feel more comfortable



Personal Story Basics

- **Grab audience attention**
- Make it a 2-3 minute movie trailer
- Share with passion & conviction
- Relate your story to others
- Support the ask






YOUR PERSONAL STORY

One of the most important things you can do is make an **emotional connection** with your legislator or their staff. Your personal story can show the representative how their legislation affects real people, their constituents, and those who vote for them.

Stories are more memorable than facts.

Stories can change current legislation

Share more details in follow up emails



Fine Tune Your Story

Time Yourself


2-3 minutes — this keeps it concise and impactful. Save the details for your follow up.

Don't Memorize

Let your story flow naturally. Use a note card with bullet points to help. This allows you to make eye contact.

Practice, Practice, Practice

Practice sharing your story. Their feedback will help you refine your delivery and enhance clarity.



PREPARATION-PRESENTING THE ASK



BE SPECIFIC & DIRECT

The more specific the ask, the easier it is to make it achievable and measurable.



MAKE IT ACHIEVABLE & MEASURABLE

It should be realistic and attainable enabling follow up.



ASK QUESTIONS

Will they support your ask?
Why or why not? What hurdles are in the way.



RESPOND TO ROADBLOCKS

Find solutions to roadblocks stopping lawmakers from supporting your ask.



Protecting Access to Healthcare

Medicaid Cuts Summary

- Among the **largest components** of the FY 2026 reconciliation proposed cuts.
- Congressional Budget Office estimates show \$800– 880 billion in federal Medicaid cuts over ten years, averaging.
- Combines **policy barriers** (work rules), **financing reductions** (provider tax caps), and **administrative hurdles**.
- Projections predict a loss of coverage for 2.3–10.3 million people, depending on which provisions persist.



Protecting Access to Healthcare

Medicaid Asks

- Safeguard Medicaid, CHIP and other vital healthcare programs
- Oppose Medicaid Work Requirements and Administrative Barriers
- Preserve and Fully Fund Medicaid Expansion & Maintain Federal Matching Rates (FMAP)
- Protect Home and Community-Based Services (HCBS)







HHS & NIH Summary

- HHS cuts are the single largest, in dollar terms, and will deeply affect public health, research, prevention, and healthcare programs.
- Cuts to the NIH, CDC, FDA, and related agencies would slow or stop critical research and impact people living with rare diseases.
- The Office of Rare Diseases Research (ORDR) and Rare Diseases
 Clinical Research Network (RDCRN) are folded into general NIH
 operations. The Agency for Healthcare Research and Quality
 (AHRQ) will be absorbed by the Office of Strategy and the
 budget "eliminates patient-centered outcomes research"
 (PCORI).
- Budget cuts at the federal level will have a ripple effect causing nongovernmental entities to lose funding and grind to a halt.



Protecting Rare Disease Research

HHS & NIH Asks

Oppose Cuts to HHS, the CDC, and FDA Proposed in H.R. 1 or Other Reconciliation Bills

Fully Fund the NIH and Key Research Agencies such as NINDS, AHRQ, and PCORI in FY 2026

Support Dedicated Funding for Rare Neurological Conditions

Urge Strengthening of Rare Disease Programs at NIH



Rare Disease Congressional Caucus

RDCC Summary

- The RDCC allows members of Congress to voice constituent concerns, collaborate on ideas, and build support for legislation that will improve the lives of people with rare diseases.
- The caucus works to advance legislation and education regarding specialized and rare health issues and diseases, and to promote patient advocacy.
- People with rare diseases often wait years for a diagnosis, travel long distances to see specialists, and face barriers to treatment due to limited research and FDA-approved options.
- Rare diseases aren't rare. There are nearly 11,000 rare disease with
 one in ten Americans living with a rare disease. More than half are
 children and 95% of rare diseases have no approved treatment.





Rare Disease Congressional Caucus

RDCC Ask- Join The Caucus

It Show Support For Bipartisan, Bicameral Efforts to improve diagnosis, treatment, and equity for those with rare and complex conditions.

It Show Support For Robust Investment In Rare Disease Research and FDA programs like orphan drug development.

Demonstrate Dedication To Legislation that expands research funding, protects patient access to care, and ensures policies reflect the needs of rare disease patients and families.

Caucus Briefings Are Four Times A Year





THE ART OF THE ASK

The "ask" is the heart of any advocacy campaign, outlining what advocates are hoping to achieve.



Use Moral Framing

Ask lawmakers to consider their role in a broader moral or ethical context.



Appeal to Legacy or Values

Connect the issue to something they care about or want to be remembered for.



Focus The Blame

Focus the "blame" on the entity or system and highlight the power of individual responsibility.

DIFFICULT CONVERSATION TIPS



Stay Calm and Professional

Do not get defensive or argumentative. Stay calm and professional.



Offer More Information

Follow up targeted towards their priorities may make a difference.



Pivot to Shared Values

Pivot the conversation to shared values to keep the conversation positive and constructive.



Keep the Door Open

Always thank them for their time and express your willingness to work together.



Acknowledge Their Concerns

Validate concerns by acknowledging their reservations or competing priorities respectfully.



Follow Up Afterwards

Stay in touch over time, as positions can shift and relationships can grow

Meeting Timing



Shows Respect For Everyone's Time



Builds Credibility & Professionalism



Ensures Your Message is Heard



Keeps the Meeting Focused

SPEAKER	APPROX. TIME	TOPIC
	30 sec. to 1 minute	Initial greetings and thanks to lawmaker/staff. Ask how much time for the meeting. Ask to take a photo at the end.
	1 to 2 minutes	Introduce the BJCSF and individuals in the meeting. Give name, city/state you are from, and conditions you have.
	1 to 2 minutes	Present the problem and Introduce asks to be brought up during meeting. Include the impact.
	2 to 3 minutes	First personal story
	2 minutes	First Ask
	2 to 3 minutes	Second Personal Story (if time available)
	2 minutes	Second Ask
	2 to 3 minutes	Questions and discussion
	1 to 2 minutes	Wrap up of asks and thank youmention successful recent legislation. Tell them we will send a follow-up email.



Foundation

Meetings are a building block to developing a relationship with your Congressmember

Momentum

The Bobby Jones CSF meetings are only one part of building that relationship

Access

Meeting with the staff can facilitate a relationship with your representative

Recognition

Building relationships allows lawmakers to recognize and consider our concerns
